[Comments included: concerns about the emissions factor being used for wood; Vermont Climate Council's plan adjusted the RCI sector's proportional emission reductions – they set 2018 (not 1990) as the reference year for determining sectoral responsibility. That amounts to a 29% reduction in emissions relative to 1990 by 2030 rather than a 40% reduction (and 76% reduction by 2050 rather than 80% relative to 1990 levels); concerns about public access to the feedback on the presentation going to DPS (DPS will aggregate and post on their website or in ePUC); A question about how the workforce element was being factored into the potential study (forthcoming in the next draft); question about how the total program cost would look on a per gallon basis.]
