Public Comment [Time Stamp 2:48:30]

[Public comments included: how LUC and avoided methane are very different from a systems analysis perspective (in relation to the degrees of certainty as is relates to the lifecycle emissions); California DOES reconcile their lifecycle and state inventory books; CHS is about reducing thermal sector emissions in Vermont, not affecting other industries or sectors; biodigesters only address the manure emissions — we shouldn't incentivize larger herds that could perversely increase methane emissions; Pike shared a report regarding flooding (re: alternatives to wood burning).]

Equity Advisory Group Report [addressed by Emily Roscoe in the meeting chat]

[Provided in the chat by Emily Roscoe: "The EAG mainly discussed the draft rule and writing the EAG report. In the draft rule, the one thing the group wanted to point out or note is what would happen to portable heat pumps, or window insert heat pumps according to the draft rule language of installed measures. Mainly discussed implications around the term "capital investment" and if that excludes this technology (that the group deemed very important for LI VTers and renters, and may address the split incentive in the CHS). This technology is not yet fully in the market, only in a pilot phase at EVT, but when it does hit the market, the group is concerned that this may be introduced and used before the CHS TRM is adjusted. So the questions are does the EAG comment on defining capital investment, how to categorize this technology, and do we consider integrating this technology into the CHS TRM so it is updated when it comes out in the market."]
