

Pursuant to 30 V.S.A. § 8124(b), each entity that sells heating fuel into or in Vermont must annually register with the Vermont Public Utility Commission (“Commission”). As required in 30 V.S.A. § 8124 (b)(4) and explained in the Commission’s order of January 24, 2024,<sup>1</sup> the Commission must publish a list of each year’s registrants. The list below includes all entities who have registered with the Commission for calendar year 2023 sales. Names in this list appear as provided by the registrants; duplicate names may appear where the entity filed two separate registrations.
